## About US The History of Methodist Senior Services

- 1961 The Conference authorized the establishment of a special committee on aging ministries.
- 1962 Granted a nonprofit corporate charter and named North Mississippi Methodist Homes for the Aging, Inc.
- 1964 The Reverend J. W. Carroll was appointed as the organization's first Executive Director. The site for its first retirement facility was selected in the western edge of Tupelo.
- 1966 Traceway Manor, MSS' first project, began.
- 1967 Traceway Manor apartments opened.
- 1972 Meals on Wheels of Lee County became an outreach ministry of MSS.
- 1975 Cedars Health Care on the Traceway Campus opened.
- 1978 Flowers Manor in Clarksdale opened.
- 1979 Trinity Place in Columbus opened.
- 1980 The Traceway Villas were added.
- 1982 The Mississippi Conferences adopted United Methodist Senior Services of Mississippi as a related institution opening the path for statewide facilities.
- 1984 Seashore Manor/Gulf Oaks Manor in Biloxi joined the MSS family.

Additions were made to the Trinity Place Campus.

Lakeside Cottages added at Traceway.

1986 - Aldersgate Retirement Community in Meridian opened.

Wesley Manor in Hattiesburg opened.

1987 - Turner-Duvall Retirement Village opened in Leakesville.

The Guy Mitchell Personal Care Center was opened on the Traceway Campus.

1990 - Flowers Manor opened a Personal Care Facility.

> Traceway made additions to Cedars Health Care and the Lakeside Cottages.

> The MSS Corporate offices were moved off the Traceway Campus.

Trinity Personal Care was opened.

1991 - MSS established a gift Endowment Fund. Dugan Memorial Home in West Point joined the MSS family.

A Personal Care Facility was added to the Biloxi Campus.

- 1993 MSS began renovating the Historic Henry Clay Hotel in West Point as a Senior Living Facility.
- 1994 Steve McAlilly is named as Bill Carroll's successor at the helm of MSS.
- 1995 MSS formally adopts its long practiced mission statement of "Serving older adults in the spirit of Christian love".

Aldersgate opened a Personal Care Facility.

- 1996 Trinity Health Care opens in Columbus. Wesley Meadows opens in Hernando.
- 1998 MSS earned the coveted EAGLE Accreditation.

Cottages added to Flowers Manor.

Riggs Manor in Raymond opened.

2003 - The organization officially changed its name to Mississippi Methodist Senior Services, Inc.

> MSS was the first to construct and operate a revolutionary type of senior care facility, The Green Houses at Traceway.

- 2005 Hurricane Katrina irrevocably damaged the Seashore Campus in Biloxi leading to its closure.
- 2008 The Martha Coker Green Houses in Yazoo City opened.
- 2011 The Seashore Board officially changed the campus name to Seashore Highlands and construction began on a new facility further inland in Gulfport.

MSS brought contract therapy services to its healthcare facilities statewide.

2012 - MSS marked its 50th Anniversary February 29, 2012.

> MSS held 3 Senior Conferences in Jackson, Hattiesburg and Tupelo with more than 2,500 seniors attending.

MSS opened an in-house pharmacy, SeniorRx.

LeadingAge honored Steve McAlilly, MSS CEO, with its 2012 Award of Honor.

2013 - MSS opened its own therapy services division, SeniorTx.

May marked the 10 Year Anniversary of the Green House Homes. MSS, Traceway and the Green House Project held a block party on May 5th.

MSS conducted the organization's 4th EAGLE Accreditation self-study and peer review in 2013.

Seashore Highlands Cove Assisted Living Facility opened with 50 suites.

Full ownership of the Henry Clay Retirement Community in West Point was transferred to MSS.

Aldersgate and Anderson Hospital formed a partnership to build a primary care clinic.

MSS adopted a Tobacco Free Policy.

2014 - The Strategic Planning Retreat gave birth to a new concept in addressing elder needs: NextAge Mississippi.

> MSS' 4th EAGLE accreditation was conferred to the organization at the UMA Conference.

> Red Carpet Learning helped MSS develop the HERE TO HELP customer service program.

Seashore Highlands converted 21 suites of the Cove Assisted Living Facility to provide Memory Support Services.

2015 - Constructed a Memory Support Green House Home at Seashore Highlands which is the first Green House located on the Mississippi Gulf Coast.

> Riggs Manor converted its 2 Assisted Living Green Houses to provide Memory Support Services.

MSS hosted statewide movie premieres of the Glen Campbell "I'll Be Me" Alzheimer's documentary, reaching nearly 1,500 Mississippians. His wife, Kim, held a Q&A panel after each showing.

The MSS Home office purchased the building beside it and renovated the additional 4,000 sf of office space.

2016 - Awarded Holleran Consulting's "Community Engagement Award" at the LeadingAge Conference.

> Traceway resident, Alice Lute, was awarded the International Eden Elder Award at the annual conference, where she also won the "Eden's Got Talent" contest for her "sit-down" comedy routine.

Traceway Manor paid off its 50 year construction note.

Trinity Place hosted MSS' first Dream Flights day in partnership with Ageless Aviation to provide honor flights in a World War II restored biplane to resident veterans or spouses. MSS would go on to host 6 statewide days in 2017 and 3 days in 2019.



2017 - The 29 Villas at Seashore Highlands were completed and occupied.

The Henry Clay began hosting The Gatherings, for all elders in West Point. It was supported by the West Point Community Foundation.

Flowers Manor led a capital campaign for improvements and converted "The Glen" into a 10-elder Green House-like home. It was renamed The Fiser-Spradling House.

Martha Coker completed construction on the community pavilion paid for by the Mary Brickell Circle.

Traceway dedicated a resident driven "Eden Garden" at Traceway Manor.

Wesley Meadows constructed a new Fellowship Center.

NextAge Mississippi launched its navigator call center and its resource website.

The Wesley Meadows Board began a feasibility study in 2017 which launched a \$1.5 million capital campaign in 2018 to raise money to build a Memory Support Green House Home.

MSS received an \$87,000 Civil Money Penalty Grant from the Centers of Medicare and Medicaid for training in the 4 skilled nursing care facilities.

Aldersgate constructed a scenic walking trail around the campus.

Music and Memory began at the 4 nursing homes and Seashore Highlands in 2017, and Aldersgate in 2018.

2018 - Began a feasibility study for Aldersgate to see if the community would support a campaign to expand the campus.

MSS adopted a No Firearms Policy.

Aldersgate was named a 2018 recipient of the Holleran Consulting "Choice Community Award." Only 2 retirement communities were awarded this distinction.

NextAge Mississippi launched the handyman and housekeeping services to Lee County.



# Milestones Our Key Areas Of Work



very year brings new challenges, changes, achievements and awards. 2018 was an excellent year for Methodist Senior Services. Our staff worked very hard to provide the very best in housing and services for elders across the state of Mississippi. Listed below are just a few of the things that took place in 2018 to improve our performance and services.



August 3-4, 2018, the Board of Directors, Members and Leadership Staff met at Eagle Ridge Conference Center to strategize new goals. Below are the stated objectives that came from that session.

- Trinity Place: Held a Blues Festival to celebrate Grandparent's Day where local bands played and raised \$3,046 for the Sunday Fund.



#### **Campus Achievements**

- Began a feasibility study for Aldersgate Retirement Community to see if the community would support a campaign to expand the campus with things such as a memory support Green House Home and a Chapel/Community building.
- Adopted a No Firearms Policy.
- Trinity and Dugan received a 5 Star Rating from CMS.
- Martha Coker and Cedars received a 4 Star Rating from CMS.
- MSS' 4 skilled nursing campuses were selected for a Music & Memory pilot program which utilizes tablets as a way to engage elders.
- NextAge Mississippi launched handyman services.

- Flowers Manor's 40th Anniversary.
- Traceway Retirement's 15th Anniversary of the Green House development.
- The Martha Coker Green House Homes celebrated 10 years of service in Yazoo City.
- Riggs Manor's 20th Anniversary. Named the activity room for Dr. Clyde Muse & Dr. George Ball
- More than 3,000 people attended awareness events featuring comedian Chonda Pierce hosted by Wesley Meadows and Wesley Manor.
- Traceway employees, Tarlyn Gates and Marie Mister, were invited to present a Green House Convivium Training video and hold an information panel discussion alongside Steve McAlilly (MSS Pressident/CEO) and Jill Wilson (Otterbein CEO) at the National Green House Conference.



#### **Employee Endeavours**

- Began using Insight Worldwide, a pre-employment assessment tool, for all campuses.
- MSS is in the top 1% of Healthiest You (telemedicine) usage for companies our size with an annual usage rate of 84.2% enrollment and an estimated savings in direct medical expenses of \$281,248.
- In 2018, there were 3 Certified Eden Associate Trainings, which yielded over 60 new Eden Associates. We also had two Reframing Dementia Trainings for elders, team and family members, which gave over 40 people a better understanding of how to care partner with a person living with forgetfulness.



Aldersgate Retirement Community was recognized nationally for its exemplary efforts in creating a culture of engagement and satisfaction. Holleran, the nation's leading research firm specializing in senior living and community engagement, named Aldersgate as a 2018 recipient of their new "Choice Community Award." The Choice Community Award recognizes organizations with strong cultures of engagement. Awards are granted by exceeding Holleran's "Engagement Index" benchmark with a mean score of 85 or higher, on a 100-point scale. This places all recipients within the top 15% of the more than 700 surveyed communities nationwide. Only two retirement communities were awarded this distinction.


